Road:

Richard Lansberry explained the John Deere mower transmission problem. It will be 3 to 4 weeks before the shop has a chance to look at it.

M. Kingman motioned to advertise for a full-time public works employee, D. Badger seconded. Motion carried, 6-0. Council was advised that an application was dropped off at the office last week.

Old Business:

Solicitor Long spoke about the Stonecrest Developer's Intergovernmental Cooperation Agreement as it relates to the Wampum Sewage Facility.

D. Badger motioned to sign the Intergovernmental Cooperation Agreement if Solicitor Long deems it acceptable, P. Morrison seconded. Motion carried, 6-0.

The new backhoe is scheduled for July delivery.

D. Badger motioned to conditionally approve the signing of the Stonecrest Developer's Component Module submitted by HRG Engineering contingent on Wampum Borough's approval and signature of the Component Module, J. Gubish seconded. Motion carried, 6-0.

Council was given copies of the conditional use letters prepared by Solicitor Long for James Frederick.

Council was advised that the remaining parts for the donated speed sign should be delivered this week.

New Business:

The 2022 Road Project bid submitted by Youngblood Paving Inc. was opened. It was the only bid received.

He said that Wampum Borough also reviewed the Sewage Component Module. They are working on the land development plan and have had some interest in occupancy that they are excited about.

The recreation committee will hold discussions regarding the potential Stonecrest land donation at a later date.
