### NEW – 2022

**Q: What is the Mohawk Area School District tax rebate program?**

A: A new program established in 2022 which piggybacks on the existing PA Property tax and Rent Rebate program.

**Q: Who is eligible?**

A: Mohawk Area School District tax residents, age 65 or older, widow or widower age 50 or older or age 18 or more and permanently disabled with income of \$35,000 or less.

**Q: How do I apply?** A: Fill out the Mohawk Area SD Property Tax Rebate Form with the Business Office (one page)

**Q: What documents do I need to apply?** A: A copy of the PA-1000 2021 form and proof of PA Tax Rebate

##### **PART D – Checklist of Required Information to send with Rebate Request Form**

- (a)  Copy of Form PA-1000 2021 (Page 1 & 2 of the Property Tax Rebate Claim) filed with the PA Dept. of Revenue
- (b)  Copy of 2021 PA-1000 Rebate Check or Statement of Direct Deposit from the State as shown in Part C, Line (b)

**Q: When can I apply?** A: July 1, 2022 through June 30, 2023.

**Q: How much rebate can I qualify for?** A: Fifty percent (50%) of the lesser of the total taxes paid to Mohawk Area School District less the PA Property tax rebate received (not to exceed \$325.00)

**Q: When will my refund be available if I am approved?** A: Checks will be available every second Monday of each month following your application received in the business office.

**Q: Who do I contact for questions?** A: Business office 724-667-7782 x1301 or x1310 .

**Q: Can I come into the school to complete my application in person?** A: Yes. The Business office will be open Tuesdays and Thursdays from 9am – 11 am for assistance.
