NOTICE OF PROPOSED ORDINANCE**

Notice is hereby given that the New Beaver Borough Council will consider at its monthly meeting to be held April 11, 2022, at 7:00 p.m. at the New Beaver Borough Building, 778 Wampum-New Galilee Road, New Galilee, Pennsylvania, 16141, along with such other general business matters as may come before the Board, an Amendment to Ordinance No. 2 of 2020 of New Beaver Borough Establishing Stop Streets Upon Certain Roads within the Borough and Prescribing Penalties for Violations thereof.

The proposed Amendment includes installing two additional stop signs at Old Route 18 and Telescope Mirror Exit of Wampum Property Owners North and at Old Route 18 and Telescope Mirror Exit of Wampum Property Owners South. The remaining parts of the proposed Amendment includes repealer and the effective date of said Amendment.

AN ORDINANCE OF NEW BEAVER BOROUGH, LAWRENCE COUNTY, PENNSYLVANIA,
FOR THE PURPOSE OF MAKING AMENDMENTS TO ORDINANCE NO. 2 OF 2020
("NEW BEAVER BOROUGH STOP SIGN ORDINANCE") SO AS TO ALLOW FOR THE
INSTALLATION OF TWO ADDITIONAL STOP SIGNS WITHIN THE BOROUGH

WHEREAS, the New Beaver Borough Council finds that an amendment is deemed necessary in order to encourage the observance of motor vehicle regulations generally.

WHEREAS, in the judgment of New Beaver Borough Council, such changes, clarifications, and amendments to the New Beaver Borough Stop Sign Ordinance is consistent with the overall best interest of the Borough and its residents.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of New Beaver Borough, Lawrence County, Commonwealth of Pennsylvania, and by this Ordinance it is hereby ordained and enacted that Ordinance No. 2 of 2020 be amended, as follows:

1. Section 3:

Add the following:

<u>STOP STREET NAME</u>	<u>INTERSECTION STREETS</u>	<u>THROUGH STREET</u>	<u>DIRECTION OF TRAFFIC</u>
50. Old Route 18	Telescope Mirror Exit of Wampum Property Owners	Old Route 18	North
51. Old Route 18	Telescope Mirror Exit of Wampum Property Owners	Old Route 18	South

2. Repealer. Any and all prior Ordinances or portions of prior Ordinances that are in conflict with this Ordinance are hereby repealed to the extent of such conflict. The remaining prior Ordinances and portions of prior Ordinances including Ordinance No. 2 of 2020, not modified herein, shall remain the same.

3. Effective Date. This Ordinance shall take effect thirty (30) days after the date of adoption by the New Beaver Borough Council, Lawrence County, Pennsylvania.
